



Build America, Buy America (BABA)

Product Compliance Guide



This document outlines Dura-Line's product compliance with The Build America, Buy America Act, which applies to all projects funded by The Bipartisan Infrastructure Law, including The BEAD Program.

Under BABA rules, construction materials and manufactured products must be manufactured in the US. Furthermore, US-mined, -produced, or -manufactured components must represent at least 55% of the total cost of manufactured products.

Please note, BABA compliance requirements must be stated on your purchase order, otherwise compliance cannot be guaranteed.
